**YARD SALE ORDINANCE**  
ARTICLE III,

REGULATIONS (adopted March 11, 1986)

**Purpose:** An ordinance to regulate the number of yard sales within the municipal limits of the Town of Northwood. The term yard sale includes garage sales, moving sales, barn sales or any other "temporary types" of outdoor sales.

1. That from and after this date the number of yard sales held along and public roadway will be limited to six (6) a year per property owner.
2. That each yard sale will require a Town permit costing \$2.00 obtained ten days prior to the sale date and permit to be posted on said property.
3. That each yard sale permit shall be for one day, but permits may be issued for consecutive days.
4. That individuals conducting the yard sales must provide off-street parking, four feet off the traveled way, so as not to interfere with moving vehicular traffic.
5. That violation of this Ordinance shall be punishable by fine of One Hundred (\$100.00) Dollars for each day an offense continues. Such fines shall in no way affect any other rights in law or equity, which the Town of Northwood may have to enforce the provisions of this Ordinance.

**Explanation:** The purpose of this Ordinance is to reduce the traffic hazards in Northwood caused by a proliferation of continuous yard sales, most of which require that automobiles park on heavily traveled highways.

Applicant agrees to comply with all of the rules and regulations as stated in the above Ordinance. If the applicant fails to comply with the Ordinance, he/she is responsible for all fines applicable according to the Ordinance.

*Applicant's signature* indicates that he/she will follow all rules and regulations and understand and agrees with the above information. Applicant understands that any/all legal matters that may arise due to their yard sale is are solely the responsibility of the applicant and in no way will the Town be held liable.
